 - a. What is the most helpful thing you are doing for yourself right now?
- 2. Ongoing work: Charles Library spaces
 - a. Review brainstorming / prioritization from last semester
 - i. 2022 Fall SLAB brainstorming activity.docx

 - iii. Since last meeting, Jackie and Caitlin met with Library Communications team. We discussed different formats for highlighting services (print, digital, where to display, etc.)
 - b. Highlighting library services & resources
 - i. Which library services and/or resources should be highlighted?
 - 1. Library stacks & leisure reading (you can browse, check out books! (beyond just academic books)
 - 2. For study rooms: highlight what resources exist to use in the rooms (cables, markers, etc.)
 - a. Improve the existing signage about using the room tech
 - 3. Subject librarian
 - ii. Format can be print signage on study room walls, signage around building, digital signage on screens
 - iii. Guiding theme? This might help us narrow down options to highlight

- 1. Increased student engagement?
- 2. Increasing student engagement with themed book displays
 - a. This is done frequently at the Law School library
 - b. Book displays in Charles where could these go?
 - Leisure reading was selected because these shelves are short, easy to put stuff on top
 - ii. Fourth floor display cases (inside and outside quiet reading room)
 - These aren't seen much maybe focus on a more visible area to start
 - We could also do more to promote the content in the cases – on social media, etc.
 - Add Instagram highlights for displays
 - iii. Would these displays have to focus just on leisure reading? Can we pull stuff from the general collection?
 - 1. @Caitlin Shanley ask Rick L. (who manages leisure collection) if we have data on the usage of these books?
 - iv. Improve signage on leisure reading to improve engagement
 - c. Law library currently has a Black History Month display
 - d. Labor organizing display?
 - e. "book of the month" connect with One Book, One Philadelphia or other national/local programs?
 - f. Rotate book displays from each college
 - g. Students could vote on Instagram "recommended by students"
 - h. Issue with leisure reading = we don't have many copies
 - i. Could do a "if you like this, try this" style display

- ii. Create a list of related titles, can pull from if copies get checked out
- i. Who is in charge of displays?
 - i. Just SLAB for now, but we could design a process together so that in the future, students can propose themes/create displays (create a submission process)
 - ii. If focus is student engagement, it would help to utilize the students' voices on their creation
- j. Would be cool to see poetry and prose/fiction and nonfiction book displays to diversify things
- k. Reach out to student orgs? Babel poetry collective, environmental clubs, Lunar lit mag
- 3. Need to consider political implications of opening this up what guidelines do we have for selecting content?
- iv. Next steps: maybe a small subgroup can focus on this in the spring semester?
 - 1. Divide into partners/teams to designate different responsibilities
 - 2. One group for leisure reading and one for stacks/cases? Separate group for question of the week?
 - 3. This is getting pretty complex maybe start out by breaking down tasks, decide who is doing which tasks
 - Dividing groups by student engagement/awareness and space
- c. Question of the week board
 - i. Where in Charles should we place these?
 - 1. Somewhere with a lot of foot traffic, like by elevator, water station, restrooms, entrances
 - ii. Question schedule
- 3. Social media takeovers: Brainstorming topics
 - a. Mick: crime and law books
- 4. New business
 - a. Reminder: Share your feedback on Library Search updates
